### 1. General Notes

### 1.1 Corporate law

The company is a stock corporation under Liechtenstein law, registered with the commercial register of the Principality of Liechtenstein under the register number FL-0002.689.035-2 as of 2 August 2022.

# 1.2 Size class pursuant to Article 1064 of the Liechtenstein Persons and Companies Act

The company is a micro entity within the meaning of Article 1064 (1a) of the Liechtenstein Persons and Companies Act (*Personen- und Gesellschaftsrecht*; PGR).

### 1.3 General book-keeping and accounting principles

The accounting takes place in accordance with the provisions of the Liechtenstein Persons and Companies Act (PGR). The financial statements have been prepared in accordance with legal requirements and the generally accepted accounting principles. The primary objective of the financial reporting is to present a true and fair view of the company's assets, financial situation and results.

The accounts are kept in CHF. The tax rate was used to convert foreign currencies into CHF as of the balance sheet date.
